**Additional instructions: 92.04G (302.4)(GRASS AND WEEDS) All premises and exterior property shall be maintained free from weeds or plant growth in excess of six inches. All noxious weeds shall be prohibited. Weeds shall be defined as all grasses annual plants and vegetation, other than trees or decorative shrubs, which shall be kept trimmed neat and orderly; however, this term shall not include cultivated flowers and gardens. Upon failure of the owner or agent having charge of a property to cut and destroy weeds after service of a notice of violation, they shall be subject to any fines, fees or penalties as prescribed by ordinance. In addition, upon failure to comply with the notice of violation, any personnel or contractor, duly authorized by the City of Pikeville Codes Enforcement officer, City Manager or his designee, shall be authorized to enter upon the property in violation and cut and destroy the weeds growing thereon, and the costs of such removal shall be paid by the owner or agent responsible for the property**

If Notice of Violation is marked above you have 7 days from the date of issue to correct the Violation unless otherwise noted above. If the Violation is not remedied the Code Enforcement Officer is authorized to issue a Citation. Fines will be assessed as indicated on the back of this form. You have the option to contest the Citation within 7 days of issuance. (Refer to the back of this form for more information)
